Janelle led the Marshfield Tiger volleyball team to consecutive state appearances in 1998 and 1999 while earning all state accolades. She then went on to play at Division 1 UW-Green Bay. While there she was three time all conference and player of the year in the Horizon League her senior season. After setting a Division 1 record for aces in a match she was portrayed in *Sports Illustrated* Faces in the Crowd. Richard received Honorable Mention All America and Third Team Academic All America. After a successful collegiate career she played professional volleyball for Pieksamaki Volley in Finland for one season. Richard has coached club volleyball for eight seasons and has been a part of high school three-time state champions of Alaska.

Melissa Lange

Melissa set the Abbotsford Falcons to three consecutive state titles while garnering honorable mention all state her senior year. From there she went on to play for Division 1 UW-Milwaukee. She earned all conference her junior and senior seasons while helping her team win three Horizon League regular season titles. UWM also made two appearances in the NCAA tournament during Lange's tenure.
