

NEW HOUSING FEE REPORT

CITY OF MARSHFIELD

AS REQUIRED UNDER SECTION 66.10014 OF THE
WISCONSIN STATUTES



BACKGROUND

This report has been created to satisfy the requirements as outlined in Section 66.10014 of the Wisconsin Statutes. Section 66.10014 reads as follows:

- 1) In this section: “municipality” means a city or village with a population of 10,000 or more
- 2) Not later than January 1, 2020, a municipality shall prepare a report of the municipality’s residential development fees. The report shall contain all of the following:
 - a. Whether the municipality imposes any of the following fees or other requirements for purposes related to residential construction, remodeling, or development and, if so, the amount of each fee:
 - i. Building permit fee
 - ii. Impact fee
 - iii. Park fee
 - iv. Land dedication or fee in lieu of land dedication requirement
 - v. Plat approval fee
 - vi. Storm water management fee
 - vii. Water or sewer hook-up fee
 - b. The total amount of fees under par. (a) that the municipality imposed for purposes related to residential construction, remodeling, or development in the prior year and an amount calculated by dividing the total amount of fees under this paragraph by the number of new residential dwelling units approved in the municipality in the prior year.
- 3) Municipality shall post the report under sub. (2) on the municipality’s internet site on a web page dedicated solely to the report and titled “New Housing Fee Report.” Municipality shall provide a copy of the report under sub. (2) to each member of the governing body of the municipality.
- 4) If a fee or the amount of a fee under sub.(2)(a) is not properly posted as required under sub. (3)(a), the municipality may not charge the fee.
