APPLICATION OF PERMIT: MUNICIPAL CODE, SECTION 8.9 (2) (USE IF STREETS- PARADES) APPLICATION WILL BE MADE NOT LESS THAT SEVEN (7) DAYS PRIOR TO SUCH PROPOSED USE, TO THE CHIEF OF POLICE. FOR GOOD CAUSE SHOWN, THE CHIEF OF POLICE MAY SHORTEN THE PERIOD OF TIME DURING WHICH SAIDE APPLICATION MAY BE FILED. IF USE OF STREES WILL BE NECESSITATE THE CLOSING OFF OF STREETS, PARKING METERS, THEN ADDITIONAL APPROVAL OF THE BOARD OF PUBLIC WORKS SHALL BE A CONDITION PRECEDENT TO THE ISSUANCE OF SUCK PERMIT.

LITTERING PROHIBITED: MUNICIPAL CODE, SECTION 8.9 (2) IT IS UNLAYFUL FOR PARTICIPANTSS IN THE EVENT TO THROW OF DEPOSIT UPON STREET OR SIDEWALK ANY OBJECTS, CANDY, ANIMAL WASTE, OR ANY OTHER MATERIAL. JUMPING ON OR OFF MOVING UNITS IS PARADE IS PROHIBITED.

PENALTY: MUNICIPAL CODE, SECTION 8.25 ANY PERSON FOUND QUILTY OF VIOLATING PROVISIONS OF THIS SECTION SHALL FORFIT NOT LESS THAT \$1.00 NOR MORE THAT \$10.00 FOR EACH SUCH OFFENSE, TOETHER WITH COSTS OF PROSECUTION, AND IN DEFAULT OF PAYMENT OF SUCH FORFEITURE AND COSTS OF PROSECUTION SHALL BE COMMITTED TO THE COUNTY JAIL FOR NOT LESS THAT ONE (1) DAY OR MORE THAT THREE (3) DAYS FOR EACH SUCK OFFENSE.
