Executive Director's Highlights November 29, 2012

1. Economic Development-

The Marshfield Area Economic Development Board (EDB) met on November 7, with the charge of reviewing the recommendation of the interview committee for the consultant to lead the strategic/action plan The Committee has recommended Redevelopment Resources and SCS BT of Wausau. The EDB will bring this recommendation to the Common Council for approval on November 27, 2012.

2. Occupancy-

Elderly/Disabled Housing-

As of today's date, Parkview-has 13 vacancies, and Cedar Rail has 3. There are 4 applicants pending

Scattered Sites-All filled

Section 8-

The Section 8 Program has 62 leased vouchers; with 1 on hold while the voucher holder "ports" (moves) from Marshfield to the St. Cloud, Minneapolis. Area. We will continue to fund that voucher after the resident leases up there and the St. Cloud Housing Authority will then "absorb" (take over the HAP)

4. Phone System-

Parkview will host the annual Christmas Dinner on December 11, and Cedar Rail will host on December 13. Residents from each building have selected vendor and menu for the event, as well as entertainment.

7. Grants Office-

Marshfield School District has approved their internal grant policy. City of Marshfield will recommend their policy to Common Council on November 27.
