## **Motion carried**

The committee discussed the Beverage Operator application of Ashley Meharg.

Police Chief Stroik said that a person can still keep their job and tend bar even without a license as long as they are not alone. After listening to the discussion and knowing all of the circumstances if you take away the points from item 2 on the memo which is 25 points were assessed because Ms. Meharg did not file a complete application (no arrests were listed) which is a violation of section 9-26 of the municipal code, the points would go down. Knowing what he knows about possession of drug paraphernalia it is possible that it could be a small pipe with very minimal residue in it so if the committee is looking at restricting or not issuing the license based on that he urged them not to do that. It is such a minimal charge and she can have this expunged from her record. He recommended issuing the license with 75 points assessed to it.

<u>JLC09-091</u> Motion by Krueger, second by Feddick to grant two (2) Temporary Class "B" Retailer's License (Picnic) to Main Street Marshfield, Inc. for July 23, 2009 and July 25, 2009. All Ayes **Motion carried** 

Police Chief Stroik added that Main Street Marshfield has hired one officer and security staff for Hub City Days.

<u>JLC09-092</u> Motion by Feddick, second by Krueger to grant a Class "B" Beer & "Class C" Wine license to Thomas House LLC; Agent – Jesse Dolan; 103 S. Central Avenue. All Ayes **Motion carried** 

The committee reviewed the memo from City Attorney Hutchinson regarding clarification of municipal code 9-32 (12) failure to remain open.

The committee directed the Police department to do spot checks on Elixir Nite Club to make sure that they are open at least once a month.

Review of Municipal Code 9-28; Investigations.

The code states that the Building Services Supervisor and the fire department either jointly or severally, within 15 days of receiving copies of alcohol applications shall make a report, in writing, to the committee, as to whether the premises meet the requirements of this chapter and the building, zoning, fire, and health codes.

Currently this is being done but the reports are sent to the City Clerk and any issues that establishments may have are cleared before the applications are brought before the committee.

The committee directed the City Clerk to revise the code to say that the reports should go to the City Clerk who then will make sure everything is cleared before the application goes to the committee.
